2026 NYS Derm Symposium

General Information

It is our pleasure to announce that we are now accepting abstracts for **Poster Presentations** and **Resident/Fellow Clinical Case Presentations** at the 2026 NYS Derm Symposium which will take place on **Saturday, October 24th 2026 at The Sleepy Hollow Hotel** (455 South Broadway, Tarrytown, NY, 10591).

Deadline for all abstract submissions is Friday, September 25th, 2026.

Notice of Acceptance will be sent via email on **Tuesday, September 29th**. All Poster / Case Report Presenters will receive **complimentary registration** for the conference.

Each abstract may only be submitted for either the Poster or Resident Clinical Case Presentation, not both. If you wish to submit multiple abstracts for consideration, you must complete a separate submission form for each.

Poster Presentation Instructions

Eligibility:

- Open to **Dermatology Residents, Fellows, and Medical Students** from all states across the USA.

Abstract Requirements:

- **Word Limit:** 250 words (excluding author information and references).
- **Structure:** Abstracts should include applicable sections based on your research type (case report, original research, systematic review, etc.):
 1. **Introduction / Background / Significance** (this should answer the question: “What was the problem?”)
 2. **Materials and Methods / Case Presentation / Objective** (this should describe how the author(s) solved the problem)
 3. **Results / Description / Main Outcomes Measure(s)** (this should answer the question: “What was discovered?”)
 4. **Conclusion(s)** (this should answer the question: “What can be learned from this experience?”)

Poster Specifications

- To be determined. All accepted poster abstracts will be notified of maximum poster specifications.

Poster Setup & Takedown Schedule (10/24/2026):

- **Setup:** 7:00 AM – 8:30 AM
- **Takedown:** 4:00 PM (posters not removed by 4:30 PM will be discarded).

Resident Case Presentation Instructions

Eligibility:

- Open to **Dermatology Residents and Fellows** from all states across the USA.
- Cases should showcase **common diseases with unusual features** or **rare diseases with significant teaching value**.

Abstract Requirements:

- **Word Limit:** 250 words (excluding author information and references).
- **Structure:** Abstracts should be structured as follows:
 1. **Background / Significance**
 2. **Case Report** (i.e., patient history, biopsies, lab data, diagnosis, treatment)
 3. **Conclusion(s)**

Oral Presentation Guidelines:

- **Time Limit:** 4 minutes
 - **Structure:** Presentations should be structured as follows:
 - **Introduction / Background / Significance**
 - **Case Report** (i.e., patient history, biopsies, lab data, diagnosis, treatment)
 - Include Clinical and/or Microscopic Pathologic images if applicable
 - **Conclusion(s)**
